May falls during Australia's Autumn when Sydney skies are generally sunny and temperatures range from approx 15C overnight to 22C daily, so medium-weight warm clothing is recommended. Sydney time during May is GMT + 10 hours.

Bank Hours

Banking hours are 9:30am to 4pm Monday to Thursday and 9:30am to 5pm Friday. ATM facilities are available in the hotel and throughout the city and suburbs and several banks are within walking distance of the hotel.

Electricity

Electricity used in Australia is 240v AC 50 cycles and a 3-pin plug is required. Tea and coffee making facilities, hair dryers and irons are provided in hotel rooms.
