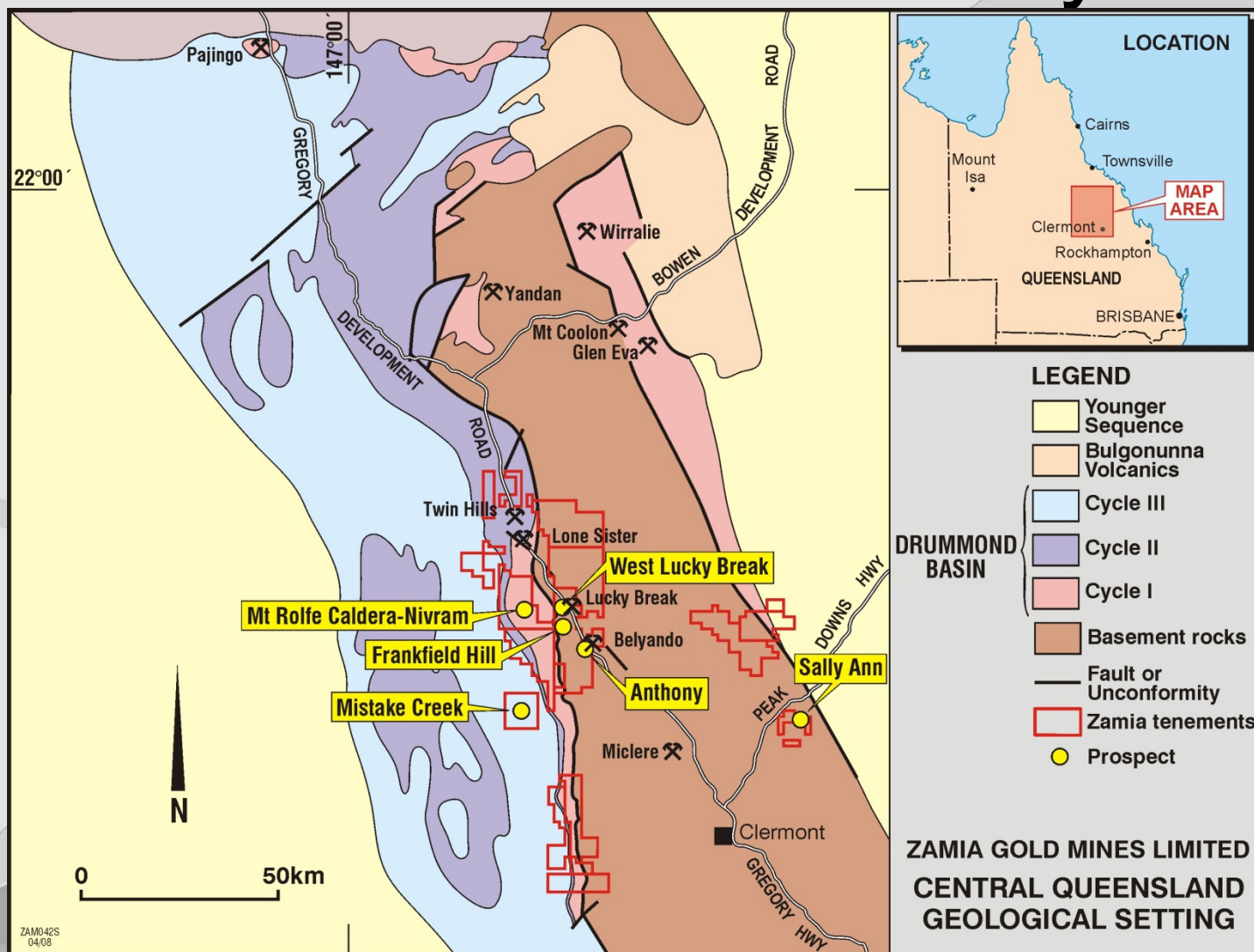

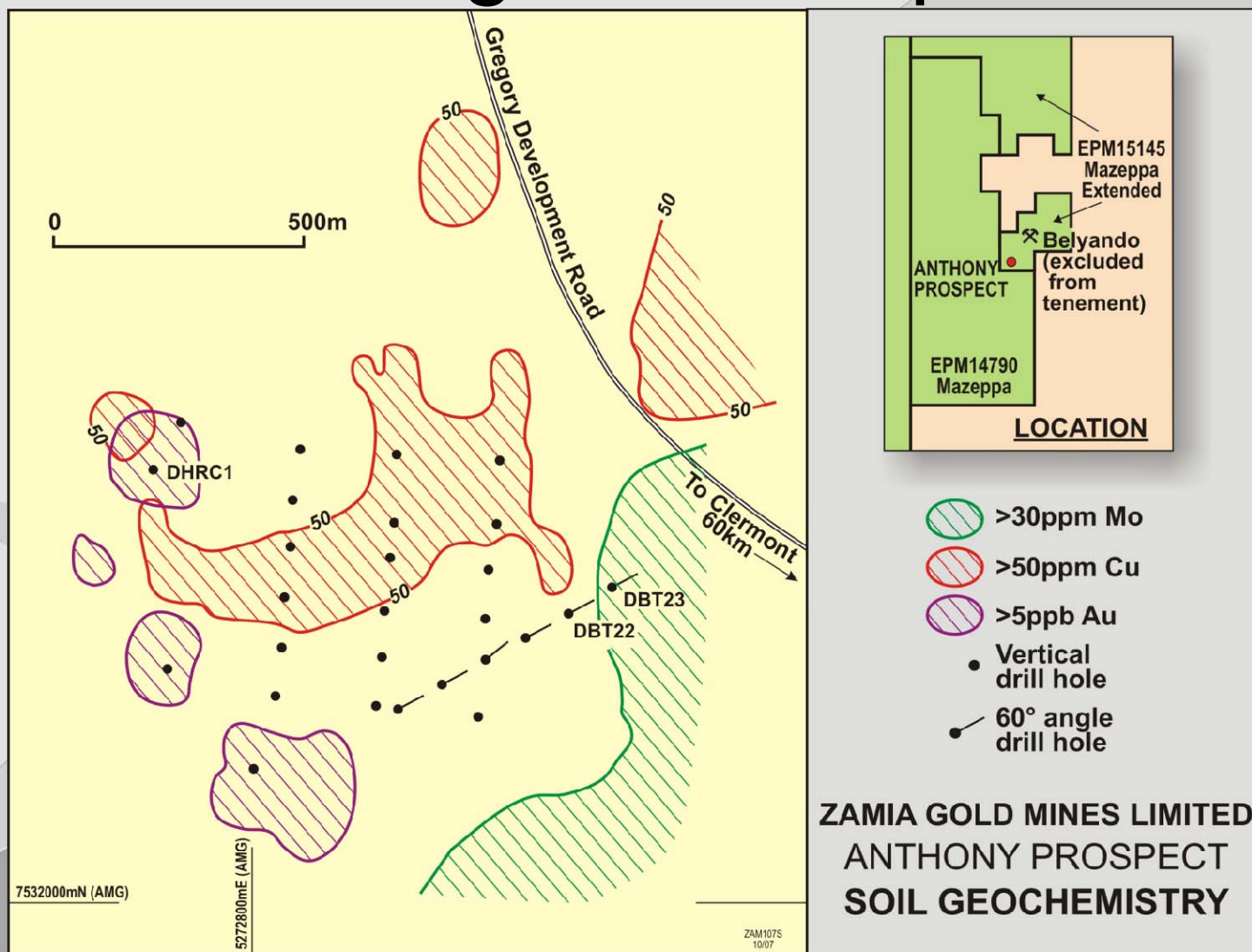

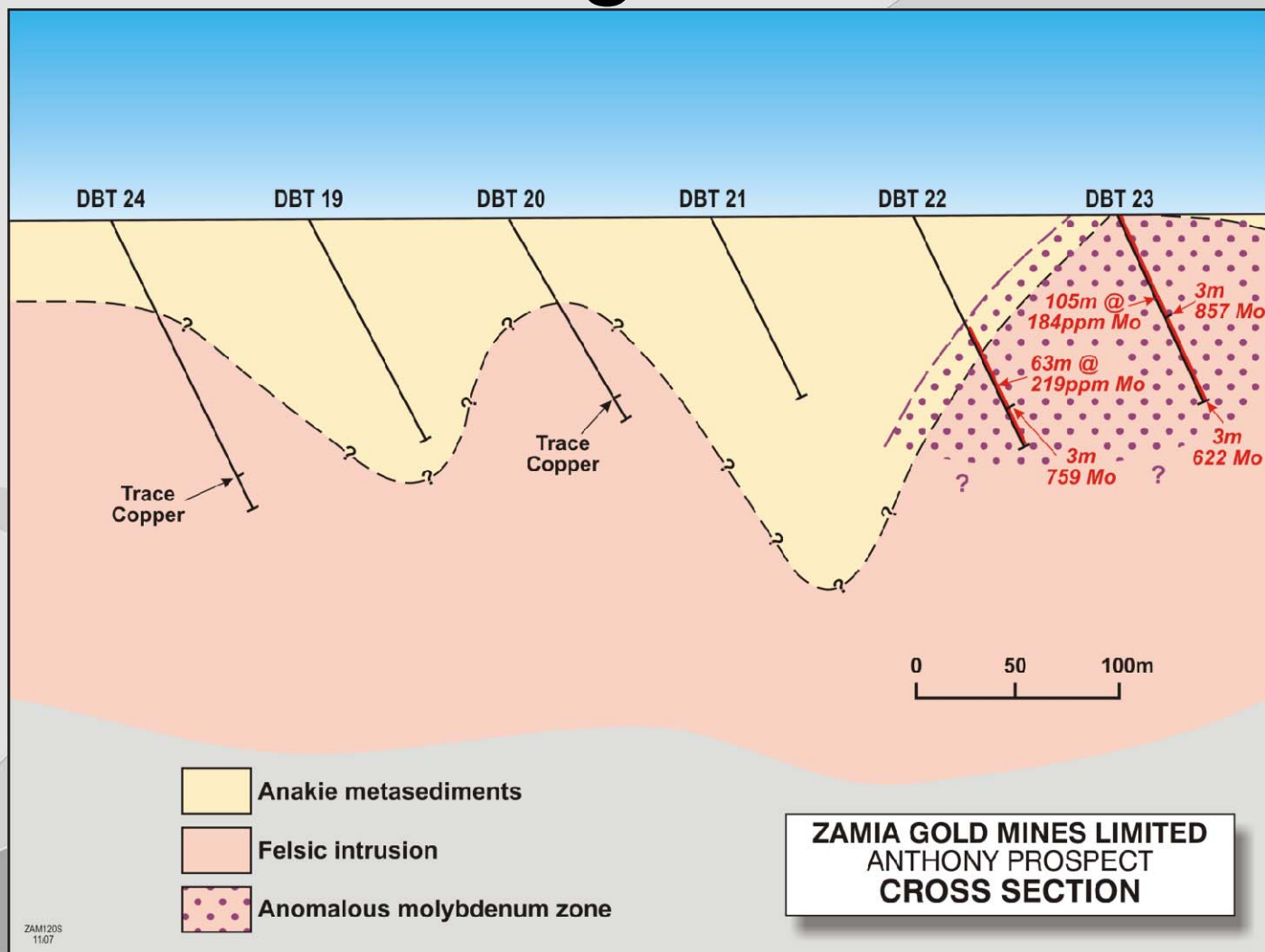
Existing Soil Samples

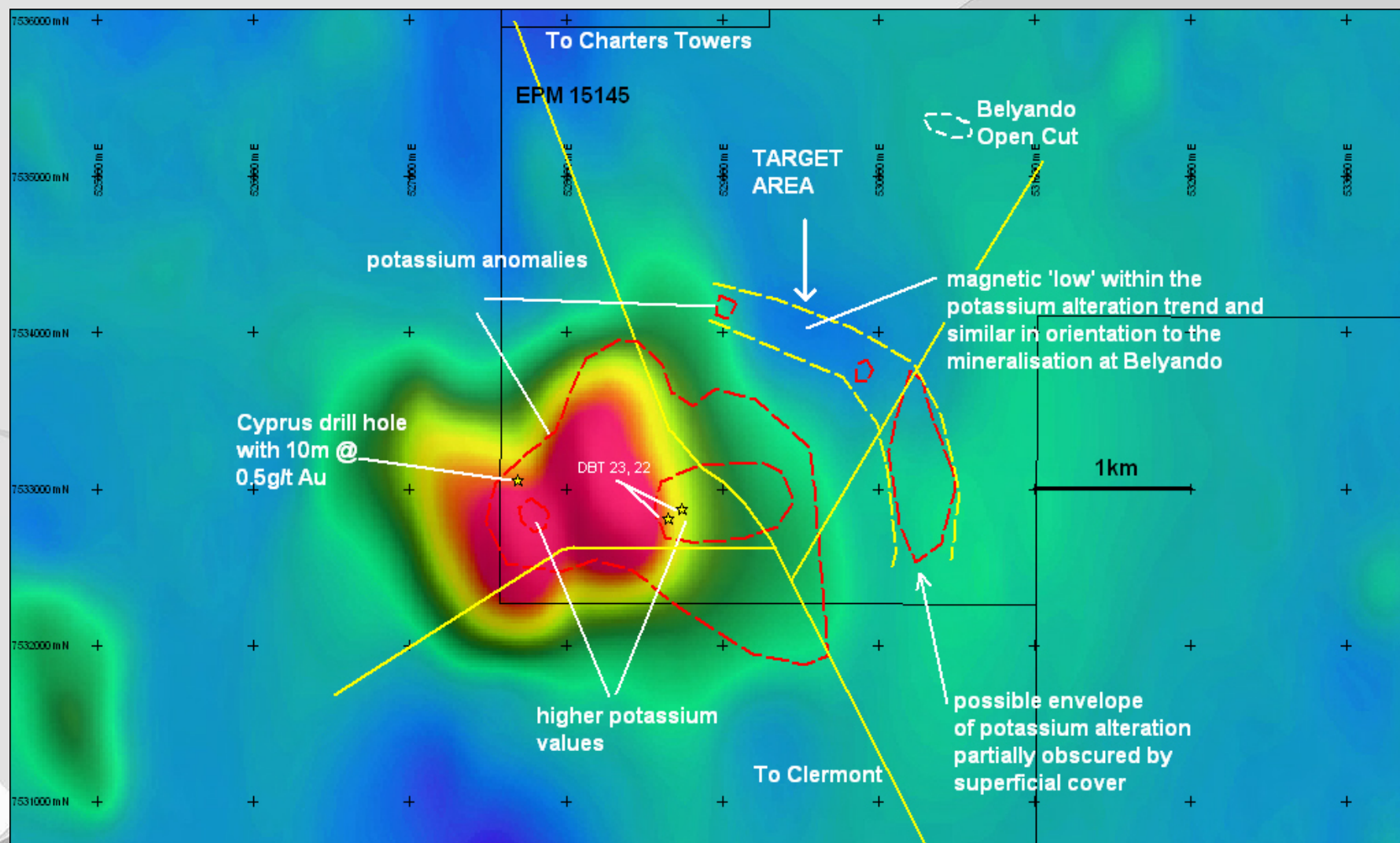
Section through old RC Holes

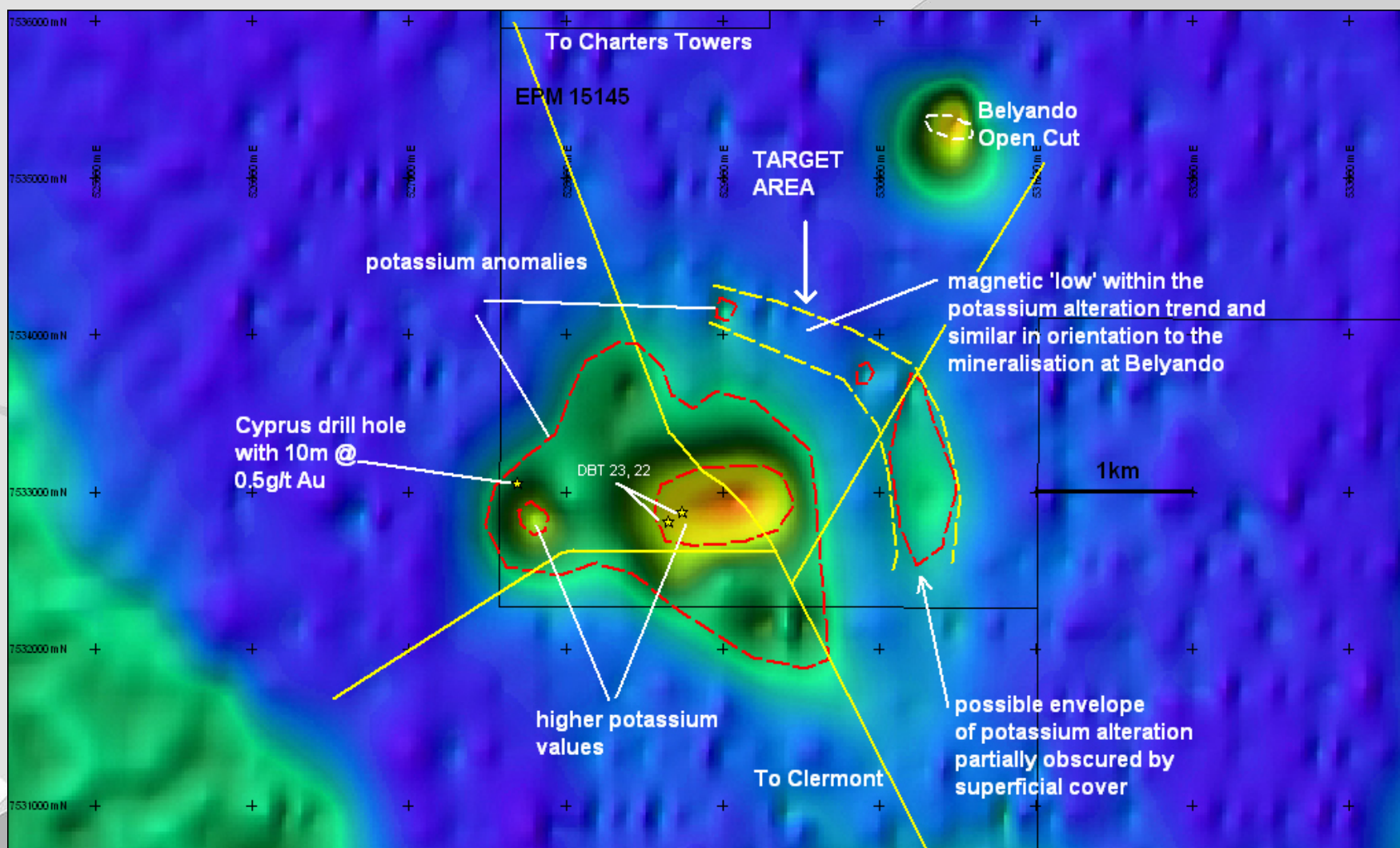

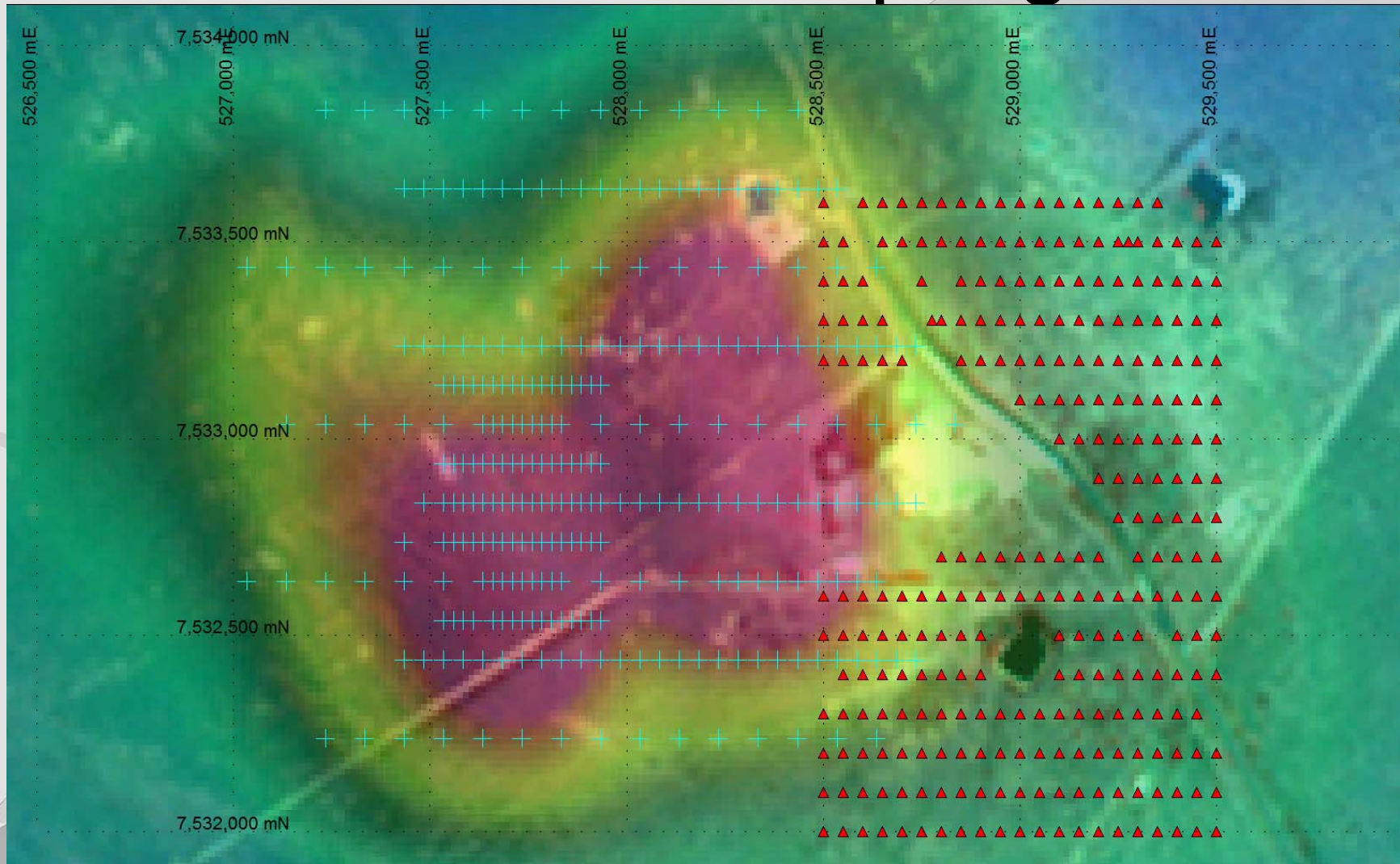

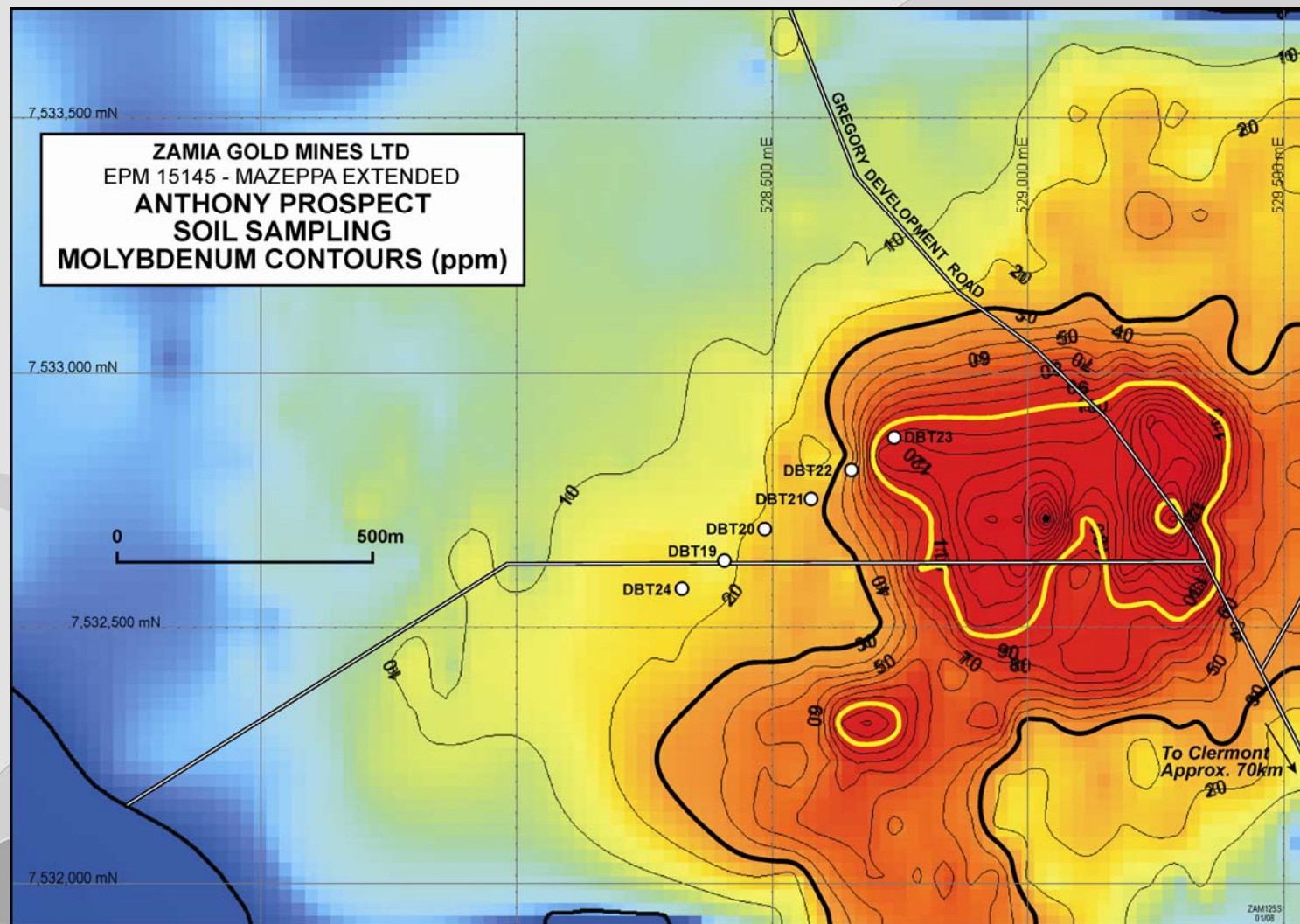
Zamia's Soil Sampling Grid

The Anthony Discovery

- Four months from field visit to discovery drill hole (in a very wet wet season!)
- Field inspection and discussion led to:
 - Interpretation of old exploration data
 - Geological mapping and chip sampling
 - Geochemical soil sampling
 - RC drilling
 - First hole discovery

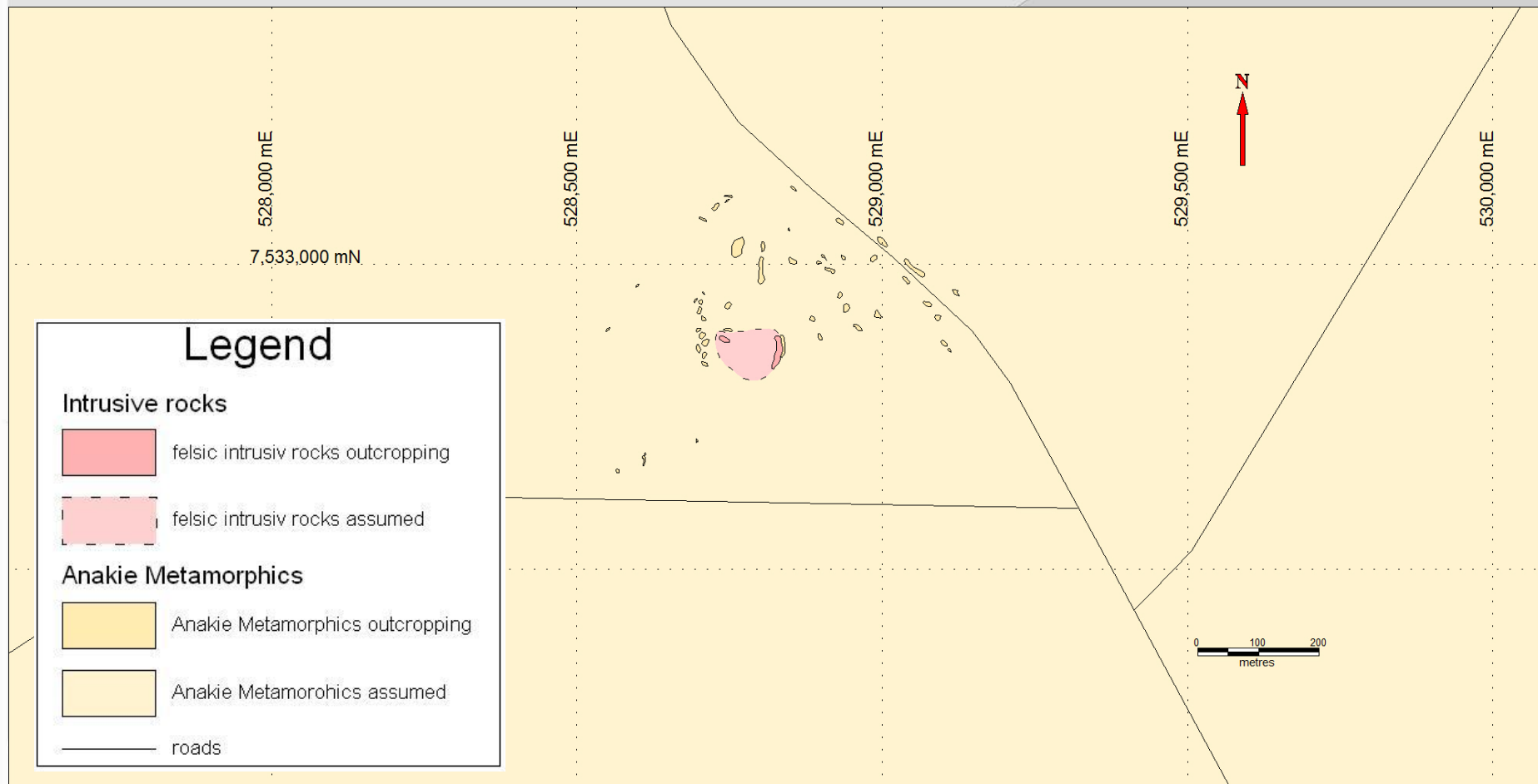

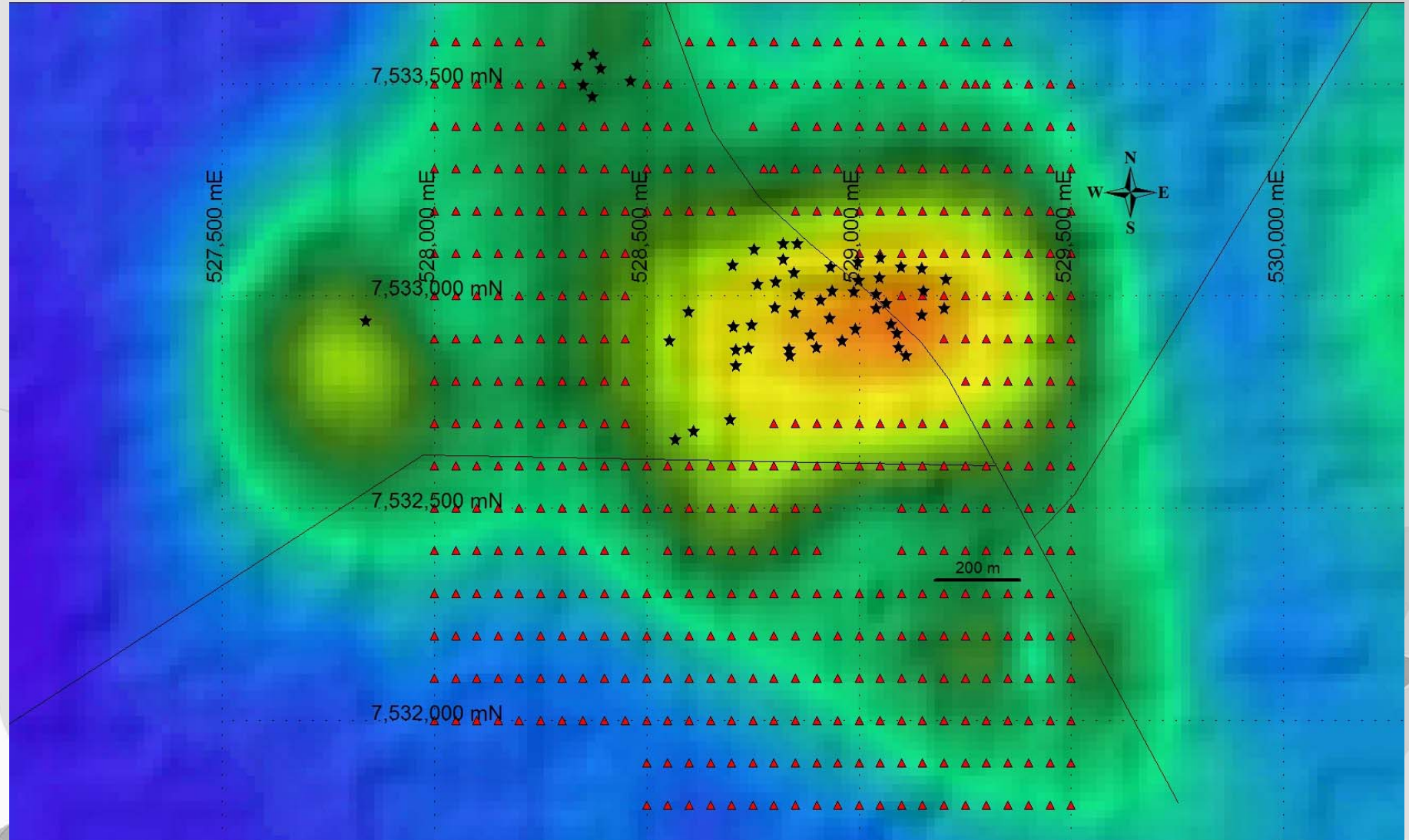

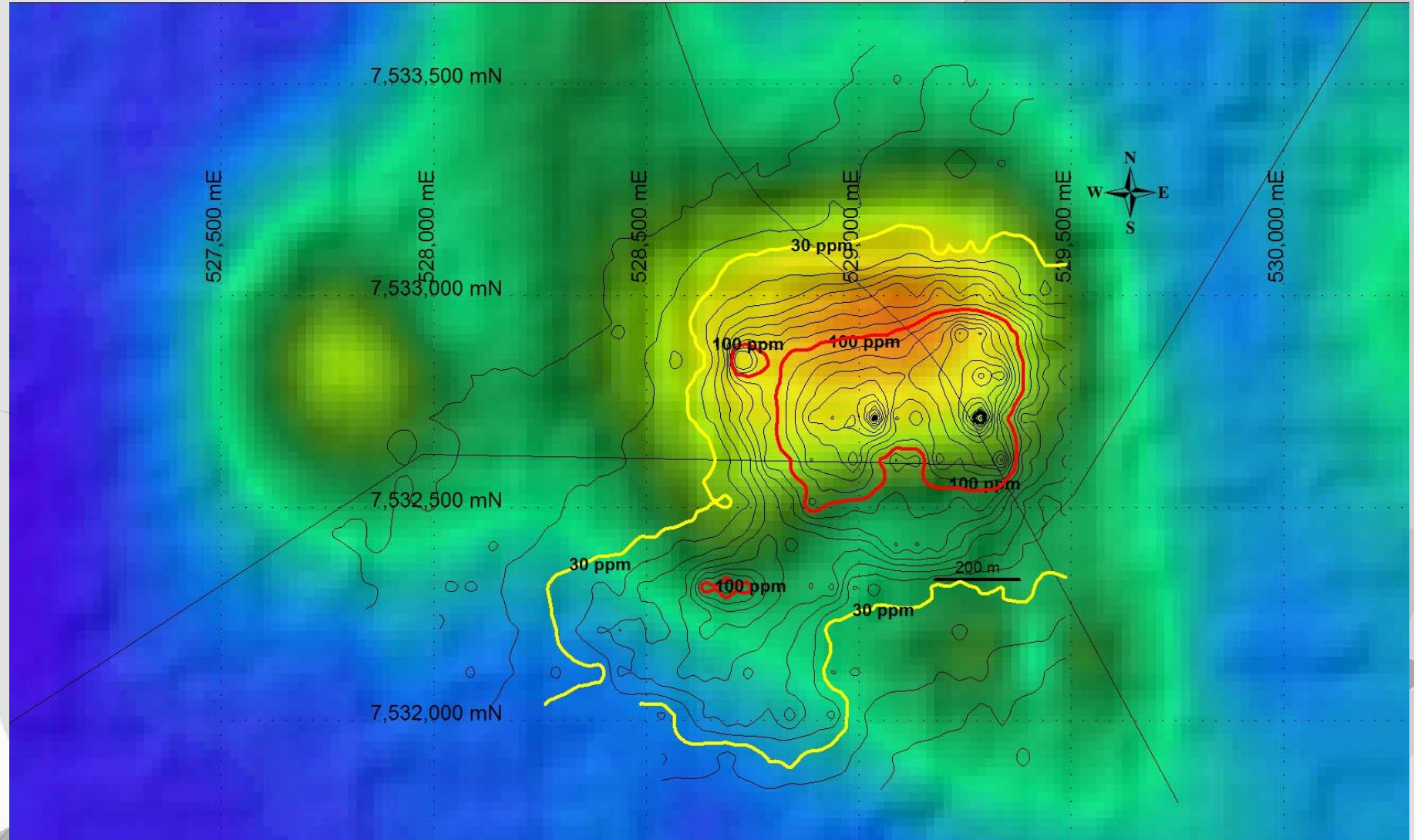
Extended soil sample grid

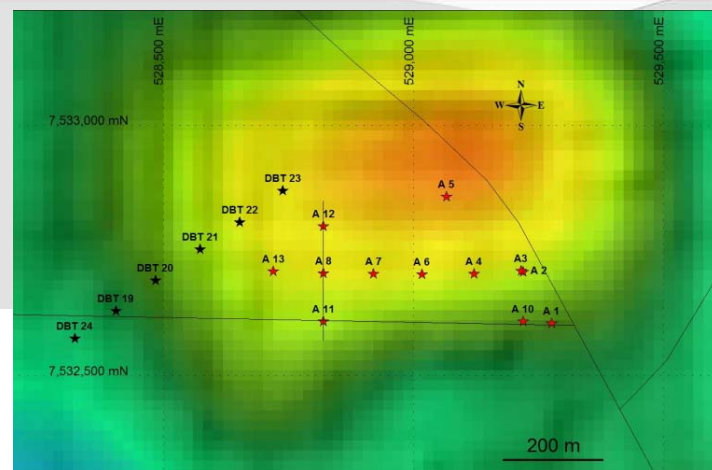
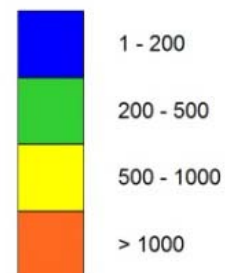
NS cross section through drill holes

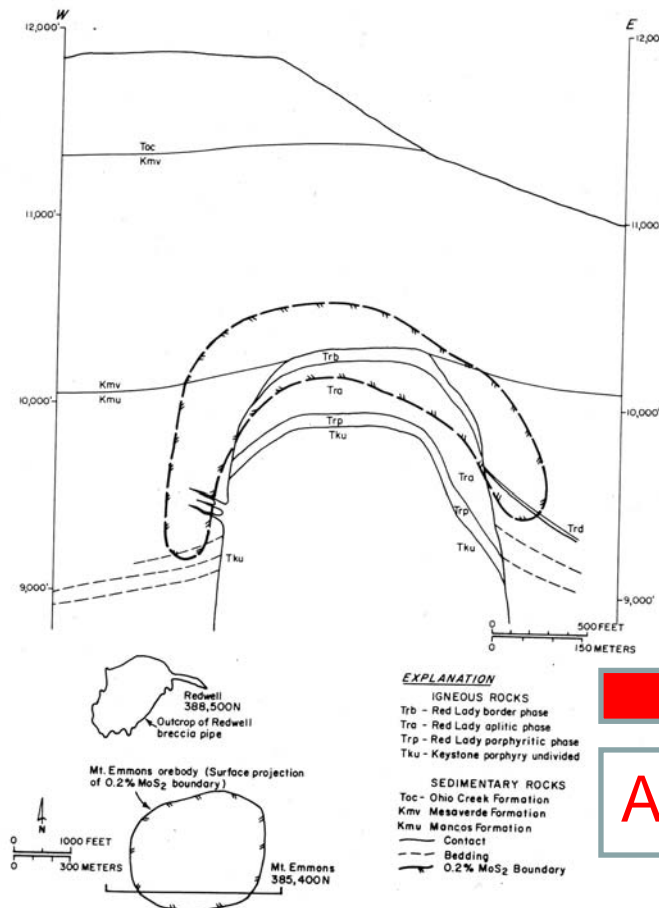
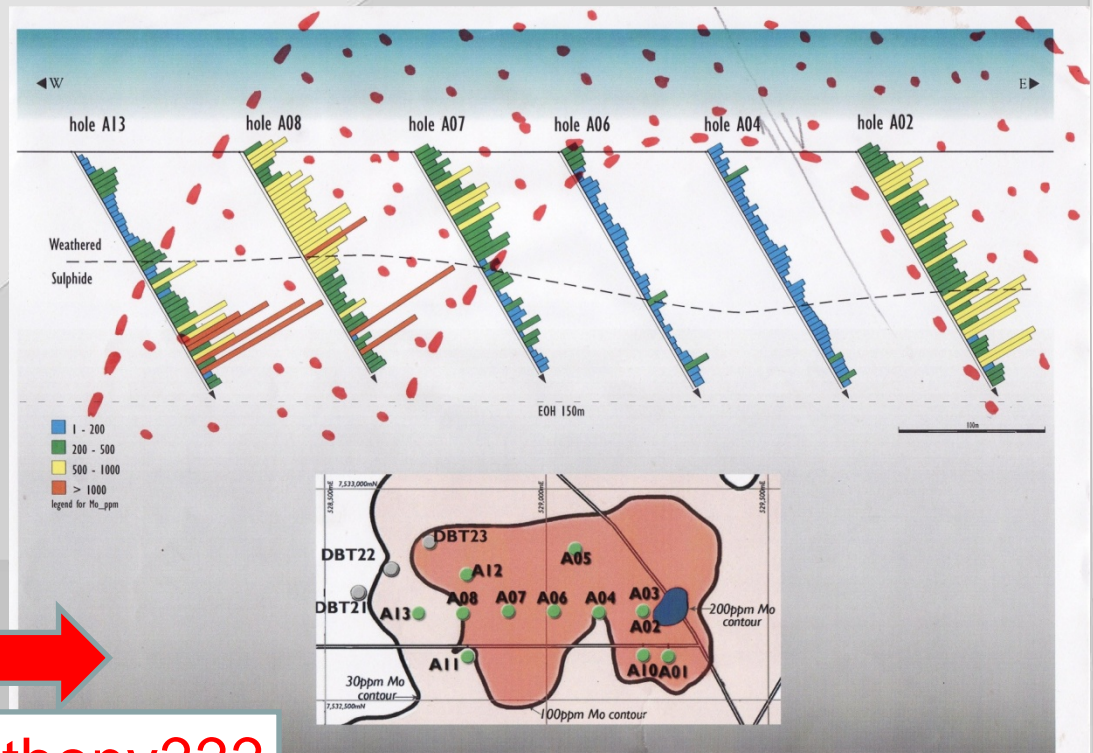
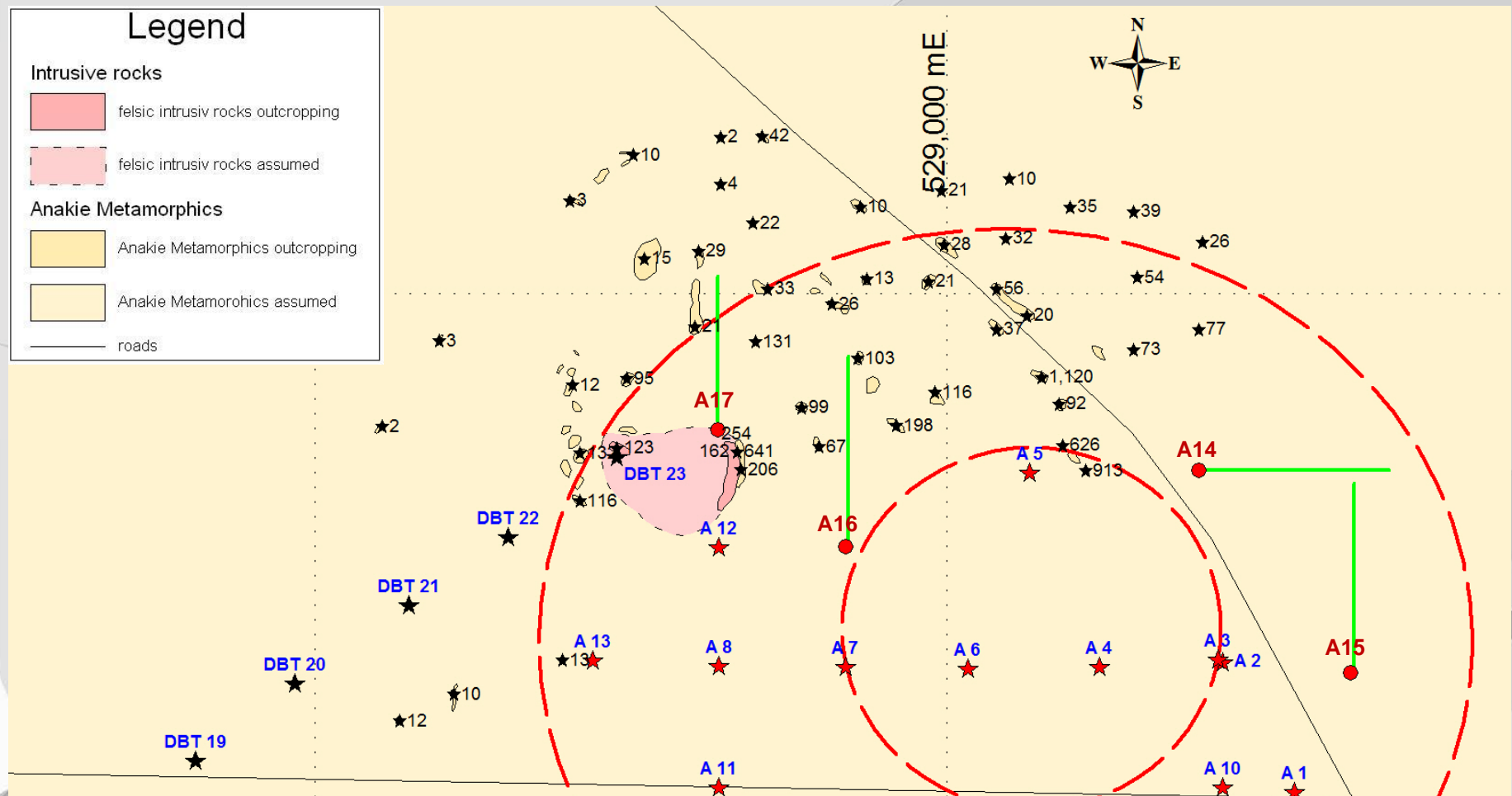


FIG. 4. Mount Emmons 385,400N section, showing generalized geology and ore zones. Generalized geologic sketch map (inset) shows location and orientation of 385,400N section with respect to the surface projection of the Mount Emmons 0.2 percent MoS₂ zone and the outcrop of the Redwell breccia pipe.

What we know

- Several different felsic intrusions at Anthony
- Mineralization in stockwork veins
- Only Mo, neither Cu nor W
- Shape of deposit not clear yet
- Results from DD will lead to a better understanding of geology

Future Program

- 10,000 m of RC drilling
- Preliminary resource estimate late 2008
- Metallurgical test work
 - Oxides
 - Sulphides
- Feasibility study?
