John Roberts AM was a founding member of SACOME and served as Council President from 2002 to 2015, during a time of advancing mining activity and the congruent expansion of SACOME. He was an inaugural member of the former South Australian Mining and Petroleum Expert Group (SAMPEG) to promote South Australia's resource sector, while also working as the founding chairman of Mithril Resources exploration company.

In 2014, John was recognised in the Queen's Birthday Honours for significant service to the mining industry, particularly to exploration and professional organisations.

John's death leaves a legacy of achievements for our sector. He played a significant role in shaping South Australia's resources industry.
